16-C. An ordinance authorizing an additional \$250,000.00 be added to the use of Jefferson Parish Sheriff's Office contract 17-D-1201 with Lamarque Ford, Inc., Crescent Ford Trucks and Courtesy Ford to purchase vehicles for the Kenner Police Department.

AN ORDINANCE AUTHORIZING AN ADDITIONAL \$250,000.00 BE ADDED TO THE USE OF JEFFERSON PARISH SHERIFF'S OFFICE CONTRACT 17-D-1201 WITH LAMARQUE FORD, INC., CRESCENT FORD TRUCKS AND COURTESY FORD TO PURCHASE VEHICLES FOR THE KENNER POLICE DEPARTMENT

WHEREAS, Louisiana law allows political subdivisions to purchase off of contracts procured by other political subdivisions, La. Rev. Stat. 38:321.1; and,

WHEREAS, the Jefferson Parish Sheriff's Office granted permission to the Kenner Police Department to utilize contract 17-D-1201 in accordance with Ordinance No. 11,310 adopted on July 20, 2017; and,

WHEREAS, Ordinance No. 11,310 adopted on July 20, 2017 authorized the use of Jefferson Parish Sheriff's Office contract 17-D-1201 with Lamarque Ford, Inc., Crescent Ford Trucks, and Courtesy Ford to purchase vehicles for an amount not to exceed \$900,000.00; and,

WHEREAS, additional funds are needed for the purchase of vehicles.

THE COUNCIL FOR THE CITY OF KENNER HEREBY ORDAINS:

SECTION ONE: That an additional \$250,000.00 in funding for the use of Jefferson Parish Sheriff's Office contract 17-D-1201 with Lamarque Ford, Inc., Crescent Ford Trucks, and Courtesy Ford to purchase vehicles for a new not to exceed amount of \$1,150,000.00 is authorized.

SECTION TWO: That subsequent modifications or amendments to this Agreement between the City of Kenner and Jefferson Parish Sheriff's Office contract 17-D-1201 may be approved by resolutions.

SECTION THREE: That the Mayor of the City of Kenner is authorized and empowered to sign any and all documents as may be necessary to give this ordinance full force and effect.
