WHEREAS, on July 20, 2017 the Mayor of the City of Kenner received a report from the Director of Inspection and Code Enforcement indicating that the structure(s) located at 2309 Kenner Avenue, Kenner, Louisiana was in a dilapidated condition; and,

WHEREAS, the owner(s) of the said structure(s), Mr. Paulo C. Datrindade, has failed to comply with all notices and/or orders to repair or demolish said structure(s); and,

WHEREAS, the structure(s) endangers public welfare; and,

WHEREAS, it is necessary that the owner(s) of said structure(s) be ordered to appear before this Council to show cause why the structure(s) should not be condemned and demolished.

THE COUNCIL FOR THE CITY OF KENNER HEREBY RESOLVES:

SECTION ONE: That a public hearing shall be held at the September 7, 2017 Kenner City Council meeting to determine whether the structure(s) located at 2309 Kenner Avenue, Kenner, Louisiana shall be abated by repair, rehabilitation, demolition or removal.

SECTION TWO: That at the September 7, 2017 Kenner City Council meeting, Mr. Paulo C. Datrindade is required to show cause why the structure(s) located at 2309 Kenner Avenue, Kenner, Louisiana should not be condemned and demolished.
