



Curbside Trash Collection Guidelines

BULKY WASTE

Uncontainerized bulky waste (including yard waste), construction debris and tree limbs must be neatly stacked or securely tied in bundles and shall not exceed four (4) feet in length, two (2) feet in diameter and 75 lbs in weight per item in order to ensure proper disposal. **ANY** yard service or tree removal performed by a contractor **shall be removed by the contractor**.

LARGE ITEMS / CONSTRUCTION DEBRIS

Items such as furniture, remodeling debris, white goods (with fluids extracted), large toys and other waste that does not fit into the IV Waste container shall be placed next to the container and should weigh no more than 75 pounds. Please don't place objects up against mailboxes, light poles, etc.

Residents who are performing light construction work that does not require a permit (i.e. sawdust & carpet removal) may place it curbside, but it must be containerized. However, carpet and padding may be left on side of the container but shall not exceed 6 feet in length.

Curbside Collection of Bulky Waste (including white goods) and Construction Debris requiring boom truck collection shall not exceed six (6) feet in length and 400 pounds in weight. Boom Truck collection will only occur one day per week on **Wednesdays**. If IV Waste does not reach your residence or small business to collect with the boom truck on Wednesday, please notify IV Waste directly by calling 504-224-8471 or emailing kennerdispatch@ivwaste.com, and IV Waste will pick-up within twenty-four (24) hours of the notification. If debris is put on the curb after trucks have completed the Wednesday route, it will not be collected until the next designated bulky waste collection day.

If a resident is unsure of their debris pile meeting the guidelines for free pick-up by IV Waste, a picture can be emailed to nonemergencyrequest@kenner.la.us. Code Enforcement will advise you. If a debris pile is left curbside for pick-up and it does not meet the free pick-up guidelines, an inspector from Code Enforcement will notify you and you will be given 10 days for removal. The resident can contract directly with any other service provider for pick-up. The Drop-off Site in Kenner is also open for large debris collection at no cost to our City residents.

All waste concrete 6 inches by 6 inches and smaller must be containerized. Waste concrete larger than 6 inches by 6 inches shall not weigh more than 75 lbs.

IV Waste is not required to remove any construction debris material that is placed curbside by a general contractor or generated from new construction or demolition where such work required a permit or ANY work done to a commercial establishment. Such debris materials placed out for curbside pickup can result in a violation being issued by the City.

CONTAINERS MAY NOT BE PLACED BY THE CURB BEFORE 3 P.M. THE DAY PRIOR TO PICK-UP AND MUST BE REMOVED FROM THE CURB BEFORE 10 A.M. ON THE DAY AFTER PICK-UP



DROP-OFF SITE: NEW DAYS AND HOURS

The City's Drop-off Site for debris disposal and recycling will be changing hours and days of operation beginning January 2, 2023. The Drop-off Site located at 1803 24th Street, will be open Saturdays and Sundays, 9:00 a.m. to 3:00 p.m. This site is FREE for all Kenner residents. A driver's license with a Kenner address is all that is needed.

The drop-off site is intended for residents to have a convenient place to dispose of their bulky waste, construction debris, white goods, scrap metal and recyclable material that is generated by the service units that are eligible for deposit and is intended to prevent unlawful dumping throughout The City of Kenner.
