### **Race Rules and Regulations**

1. Current rabies vaccination record must be presented at the time of check-in.
2. Entry fee (\$15 per dog) must be paid in the form of cash or credit card.
3. Two race handlers are required for each dog.
4. Dog must be kept on a 6 foot or shorter leash at all times outside of the race.
5. Owners are strongly recommended to have their dogs up to date on all vaccinations and to have them wear an ID tag.
6. Owners are responsible for cleaning all doggy messes.
7. Dogs must be socialized with other dogs and people.
8. Dogs in heat should be left at home.
9. Children under the age of 12 must be accompanied by an adult 18 years or older.
10. Owners must remove their dog and leave the event if their dog acts aggressively toward people or other dogs or poses any safety risk to others.
11. No food (human or dog) is allowed on the racetrack area.
12. You may bring your dog's favorite toy to use during the race to encourage your racer. Toys may not be larger than 8 inches.
13. Race length is approximately 20 yards on asphalt (from 421 Williams Boulevard to 415 Williams Boulevard).
