WITNESSES TO BE SUBPOENAED

RULE II, Section 2.11, Subsection D(2): *No subpoena will be issued unless a written request for the issuance of subpoenas is received in the office of the Director of the Department of Civil Service no later than ten (10) calendar days before the date fixed for the hearing. The request for subpoenas shall contain the names of the witnesses, the street addresses at which the witnesses can be served, and a brief statement of what is intended to be proved by each witness.*

RULE II, Section 2.11, Subsection D(10): *Except with the prior approval of the Board, each party to an appeal shall be limited to not more than five subpoenas for the testimony of witnesses in connection with any merits hearing. Where a request for subpoenas exceeds this limit, the parties are encouraged to discuss the possible stipulation of witnesses' statements in lieu of live testimony.*

RULE II, Section 2.11, Subsection D-(3): *No subpoena for the production of books, papers, or other items will be issued unless a written request for the issuance of subpoenas is received in the office of the Director of the Department of Civil Service no later than ten (10) calendar days before the date fixed for the hearing. The request for a subpoena for books, papers or other items shall contain a description of the items to be produced in sufficient detail for identification and shall contain the name and street address of the person who is to be required to produce the items and a brief statement of what is intended to be proved by each item.*
