

EMERGENCY AT WATERFORD 3 NUCLEAR POWER PLANT

Entergy's Waterford 3 Nuclear Power Plant is situated in the community of Taft, located on the westbank of the Mississippi River in St. Charles Parish, approximately 14 miles south west of Kenner, Louisiana. In the event of a radiological emergency at the plant, State and Parish officials will decide how severe it is and what protective measures are necessary. Most problems will not affect residents or persons travelling through the region. However, if the experts decide there is a serious emergency, you may have to protect yourself.

How will you KNOW if there is an emergency at Waterford?

- Sirens will sound (St. Charles and St. John the Baptist Parish).
- Radio and TV stations will broadcast warnings throughout the region.
- Community alert systems will issue notices using phones and email.
- If necessary, firemen and police officers may go through the area to warn you.

What should you DO if an emergency occurs at Waterford?

- Stay calm.
- Prepare your Family Disaster Kit.
- Prepare your automobile.
- Tune your radio or TV set to one the stations below for OFFICIAL information:
 - Radio – WWL 870 AM**
 - Radio – WLMG 101.9 FM**
 - Radio – WWL-FM 105.3 FM**
 - Radio – 1370-AM (St. Charles)**
 - TV – Channels: 4-WWL, 6-WDSU, 8-WVUE, 26-WGNO**
 - COX 6 (St. Charles Parish)**
 - Comcast or RTC - Channel 15; ATT UVerse 99 (St. John)**
- If you live, work or regularly travel within the area immediately around the Waterford plant, refer to the Waterford 3 map. Follow the advice given for the Section of the attached map you are in.

How could KENNER be affected by an emergency at Waterford?

- Kenner IS NOT within the 10 mile Emergency Planning Zone (EPZ) around the Waterford facility and it is unlikely Kenner will be directly affected by any event occurring at the plant.
- In the event of an emergency at the plant, Kenner officials will monitor the situation and coordinate with parish, state and federal authorities.
- If a major incident does occur at Waterford and residents within the 10 mile EPZ around the plant have to evacuate, then Kenner would assist officials in St. Charles and St. John Parishes by hosting a local Community Reception Center (CRC).
- If protective measures are necessary for local residents, information will be broadcast via all media including TV, radio, social media sites, and via emergency alert systems.

What should you NOT do in the event of an emergency at Waterford?

- DO NOT panic. Don't react to rumors or unconfirmed, unofficial reports.
- DO NOT use your telephone unless it is absolutely necessary.
- DO NOT call or go to your children's school. Special procedures will be employed by officials at local schools to take care of area school children.
- DO NOT travel to another area. Remain in the section of the map you are in unless told otherwise.

What if you are told to PROTECT YOUR BREATHING?

- Cover your nose and mouth with a handkerchief or cloth.
- Close the windows and doors if you are in a building or car. Turn the vent or A/C to "re-circulate" or "maximum" if you are in a car.
- Turn off window and attic fans.
- Turn heating or cooling systems to "re-circulate" or "vent closed" if available. If not, turn off heating or cooling systems.

What if you are told to SHELTER IN PLACE?

- Go inside your house or some other building.
- Stay inside until your radio or TV says you can leave safely.
- Close all doors and windows.
- Turn off window and attic fans.
- Turn heating or cooling systems to "re-circulate" or "vent closed" if available. If not, turn off heating or cooling systems.
- Keep your pets inside.
- Listen to the radio or TV stations for further advice.

What if you are told to EVACUATE?

- Be sure that this order applies to your section of the map. If it does, follow the next steps.
- Get your family together and prepare to leave. If you have children in school, they will be taken to a designated Community Reception Center for their school. You will be told by radio or TV where to pick up your children.
- Pack only what you will need most:
 - prescription drugs
 - special medicines
 - first aid kit
 - personal identification
 - baby supplies
 - portable radio
 - flashlight
 - cell phone
 - batteries

- checkbook and credit cards.
- Proceed to a designated **Community Reception Center (CRC)** where you will be asked to register and may be asked to take part in screening.
- Additional emergency shelters may be established to support evacuees.
- Obey instructions from emergency managers and public health officials.

What about my house?

- Turn off the lights and household appliances.
- Leave the refrigerator and freezer on.
- Lock your house.

When can I return home?

Once Federal, State, Parish and Public Health officials determine that it is safe to re-populate, you will be allowed back to your residence. Official notices will be issued via radio, TV and community alert systems.
