**SUMMARY NO. 1346**

AN ORDINANCE AMENDING THE COMPREHESIVE ZONING ORDINANCE FOR THE CITY OF KENNER, ORDINANCE NO. 2427, BY AMENDING SECTION 6.02 (A) BY ADDING AN ADDITIONAL PERMITTED USE TO BE NUMBERED 6.02 (A) (15) AND BY AMENDING SECTION 7.02 (A) BY ADDING AN ADDITIONAL PERMITTED USE TO BE NUMBERED 7.02 (A) (3), PROVIDING THE REGULATION OF GARAGE, YARD SALES AND CRAFT SALES.

BE IT ORDAINED BY THE CITY OF KENNER COUNCIL, that Section 6.02 (A) of the Comprehensive Zoning Ordinance for the City of Kenner, Ordinance No. 2427, by amended by adding a new and is hereby amended as follows:

SECTION 6.02 PERMITTED USES: BUILDING OR LAND SHALL BE USED FOR THE FOLLOWING PURPOSES:

**GARAGE, YARD SALES AND CRAFT SALES ARE PERMITTED PROVIDED:**

- A. No more than two sales at a given dwelling unit in any 12-month period. The duration of garage, yard sales and craft sales shall not exceed three (3) consecutive days.
- B. No items shall be purchased for a garage, yard sale or craft sale for the purpose of resale.
- C. One non-illuminated sign not exceeding six (6) square feet in area shall be permitted. Said sign shall pertain to the garage, yard sale or craft sale only and shall be located on private property said sign shall be permitted for the three-day period only.
- D. The purpose of garage and yard sales is to allow residents to dispose of unnecessary or items that are no longer needed which the family members have accumulated.
- E. The purpose of craft sales is to allow residents to sell items which have been handcrafted or handmade in the home.
- F. All garage and yard sales or craft sales can only be held between the hours of ~~10:00 a.m.~~ and 5:00 p.m.
- G. Craft sales will be prohibited between December 1<sup>st</sup> and December 31<sup>st</sup> of each calendar year.
- H. Prior to having a garage, yard sale or craft sale, a resident shall first obtain A permit from the Department of Code Enforcement and the permit shall be Conspicuously displayed during the sale.
